

Recognize Volunteers

Winning the Fight for Stable Housing

Our community financial stability goal is to increase the number of financially stable households by 15% (1,325 households) by 2020. This means that 15% more families will make more than 250% of the Federal Poverty Line (FPL). For a family of three, this means earnings of \$50,400 or more; for a family of four, this is \$60,750 or more.

More than 50 years ago, food was the biggest expense of a family's budget at about one third. Today, housing and transportation are the largest expenses in a family budget. For families with children, childcare is also a significant expense.

Given these differences, the Iowa Policy Project determined families require an annual income comparable to 250% FPL in order to meet basic needs on a frugal budget. We set the goal at 250% of the FPL in 2009 because achieving this level of income allows families to meet basic needs like food, housing, and transportation, as well as move past benefit gaps that make long-term progress difficult.

Since 2009, the number of financially stable families in our service area of Benton, Cedar, Iowa, Jones, and Linn Counties increased to 70.8% in 2016–a 10.3% increase since 2009. This is equivalent to an estimated **1,268 households–meaning less than 100 left to achieve our goal!**

Additionally:

- 23.1% fewer family households lived below the federal poverty.
- 16.2% fewer family households lived at 100–250% of the federal poverty line.
- The number of single female-headed households with children younger than age 18 decreased by 17%.
 - This household type makes up one in five households in the five-county area and is the household type most likely to be below 250% FPL.
